



Dean's Measure No. 7/2023 Payment of scholarships in doctoral study programs

In accordance with the valid Scholarship Regulations of the University of South Bohemia in České Budějovice (hereinafter referred to as the "Scholarship Regulations"), this Measure regulates the method of payment of scholarships in doctoral study programs (DSPs) at the FFPW USB.

1) Scholarships will be paid to full-time students monthly according to the following table:

Note: In brackets, there are given scholarships for students of the FFPW USB operating outside the laboratory or workplace of the FFPW USB, if it is not an institution participating in the implementation of the study program according to the accreditation.

 - c) According to the Dean's Measure concerning the extraordinary scholarship for DSP students at the FFPW USB in connection with their place of accommodation
- 2) The exact amount of the scholarship for support of research, development and innovation activities of students (hereinafter referred to as the "Scholarship for support RDI" in the table in point 1) is determined by the Dean after the discussion in the Dean's collegium.
- 3) In addition to the scholarships listed above, the student may receive other types of scholarships for support of RDI when solving an individual project GA JU under the contract of the project; scholarships for support of RDI from the RVO budgets of laboratories, institutes or workplaces; premium scholarships for publication of outputs, extraordinary scholarships, scholarships supporting study abroad, etc.). The allocation of these scholarships is governed by other applicable laws (e.g. the Act No. 111/1998 Coll., about universities and about changes and additions to other Acts, as amended and internal regulations and standards of the USB and the FFPW USB).



- 4) The monthly amount of the regular scholarship measured according to paragraph 1 of this Measure will be in the standard period of study increased for up to two best first-author publications related to the solution of the dissertation thesis and will be published in journals indexed in the database Web of Science, Science Citation Index Expanded (with the exception of articles in the magazines of the MDPI publishing house). The Vice-Dean for Science and Research (currently Antonín Kouba, akouba@frov.jcu.cz) and the Officer for Ph.D. Study and Foreign Relations (currently Lucie Kačerová, lkacerova@frov.jcu.cz) must be immediately informed by the student about the acceptance of the publication. The increase will take place from the following month if the information was provided by the 25th of the given month inclusive. The amount of this scholarship takes into account the average ranking of the journal in the categories to which it belongs, according to the Journal Citation Reports. The decisive aspect is the order (quartiles) of journals according to the Article Influence Score (AIS) or impact factor (IF; if they do not have AIS). The increase in the regular monthly scholarship will be following:

- 5) The monthly amount of the regular monthly scholarship according to paragraph 1 of this Measure will be decreased:
- up to CZK 8,000 (CZK 5,000) for students in the 4th year of study of 1. semester if the student does not send any manuscript as the first author related to the solution of the dissertation thesis in the paper's editorial office according to the Study and Examination Regulations of DSP at the FFPW USB.
 - to CZK 5,000 CZK (CZK 3,000) for students in the 4th year of study of 2. semester if the student does not send any manuscript as the first author related to the solution of the dissertation thesis in the paper's editorial office according to the Study and Examination Regulations of DSP at the FFPW USB.
 - up to CZK 0 for students in the 5th year of study of 1. semester if the student does not send any manuscript as the first author related to the solution of the dissertation thesis in the paper's editorial office according to the Study and Examination Regulations of DSP at the FFPW USB.
 - to CZK 5,000 CZK (CZK 3,000) for students in the 5th year of study of 1. semester if the student does not have accepted any manuscript as the first author related to the solution of the dissertation thesis in the paper's editorial office according to the Study and Examination Regulations of DSP at the FFPW USB.
 - to CZK 0 for students in the 5th year of study of 2. semester if the student does not have accepted any manuscript as the first author related to the solution of the dissertation thesis in the paper's editorial office according to the Study and Examination Regulations of DSP at the FFPW USB.



- 6) The monthly amount of the regular monthly scholarship will also be shortened based on the initiative of the student's supervisor, the head of the laboratory where the student works, or the director of the relevant institute for another breach of student's obligations and duties or in cases where there are no grounds for awarding individual scholarships. The change of the scholarship in cases that are not obvious from related regulations or other legal documents (e.g. project solution agreements) is decided by the Dean of the Faculty after discussion in the Dean's Collegium.
- 7) In the case when the student was entitled to the payment of scholarship during the month (e.g. after the enrolment to study) or the entitlement to payment of scholarship ends during the month (e.g. graduation, transition to a combined form of study, etc.), the scholarship is paid in full if the entitlement period lasted for more than half of the month. Otherwise, the scholarship is paid in a proportional amount.
- 8) The exceptions from this Measure are decided by the Dean after the discussion in the Dean's Collegium.

This Measure cancels Dean's Decision No. 11/2022.

This Measure takes effect on 24th April 2023.
